

Closed Thuesday afternoon at 1 PM. Open Sunday between 11 AM and 5 PM Arrival time preferably between 10 AM and 2 PM. Sunday between 11 AM and 2 PM Departure between 10 AM and 6 PM. Sunday between 11 AM and 5 PM

→ Arrivals and departures must be only by an appointement.

We reserve the right to deny any animal admission which appears on arrival to be in bad health. The inoculation book is required upon arrival, failure to produce it will result

in refusal to admit the animal and the loss of any deposit. Reservation is only considered as definite if a deposit of 25% has been receiveD.

Failure to arrive on the appointed date of boarding will automatically be seen as a cancellation, and the deposit paid will be kept as restitution for loss of income.

Every dog entering the kennels must have its yearly inoculations for distemper, hepatitis, leptospiris, parvovirus and kennel cough. A rabies injection is obligatory for dogs coming from an area where rabies is known to be. The dog should be treated for fleas and worms preferably 2 weeks prior to arrival.

D.P.I is veterinary controlled. The vet is available immediately in an emergency

On admission the dog's master must inform us if his dog is aggressive or sociable. If the dog is sociable he will be allowed to play with other dogs in our enclosed park. At night time he will be locked in his kennel. If your dog is aggressive it will be segregated from the other dogs. In any case, It will be heated with affection.
